INTRODUCTION

1 Legal requirement

- 1.1 Adopting a publication scheme is a requirement of the Freedom of Information Act 2000 (the Act). This Act promotes greater openness and accountability across the public sector by requiring all 'public authorities' to make information available proactively through a publication scheme.
- 1.2 'Public authorities' are defined in the Act and include universities, further education colleges and sixth form colleges plus any wholly owned subsidiary companies.

2 What is a publication scheme?

- 2.1 A publication scheme is a document which describes the information a public authority publishes, or intends to publish. In this context, 'publish' means to make information available routinely. These descriptions are called 'classes of information'. The scheme is not a list of the actual publications, because this will change as new material is published or existing material revised. It is, however, the public authority's commitment to make available the information described.
- 2.2 A publication scheme must set out the classes, or categories, of information published. It must also make clear how the information described can be accessed and whether or not charges will be made.

3 The College's publication scheme

- 3.1 Sparsholt College Group (the College) has adopted the model publication scheme developed for the Further Education sector by the Information Commissioner's Office (ICO).
- 3.2 The classes of information within the College's publication scheme are:
 - Who we are and what we do
 - What we spend and how we spend it
 - What our priorities are and how we are doing
 - How we make decisions
 - Our policies and procedures
 - Lists and registers
 - The services we offer
- 3.3 A publication scheme relates to 'published' information, that is, material already been prepared in a format ready for distribution.

4 Accessing information covered by the publication scheme

- 4.1 Guidance is given in the scheme to where to access the information which the College routinely publishes on its websites for each of the classes of information.
- 4.2 To request information available through our publication scheme which is not available via the College's websites, please contact the College's Freedom of Information (FOI)

Officer (details at section 7 below). A reasonable charge may be made to cover printing and postage costs if relevant.

5. Information not covered by the publication scheme

- 5.1 You have the right under the Act to request any information held by a public authority which it has not already made available through its publication scheme. We are not required to release information to which an exemption in the Act legitimately applies.
- 5.2 Requests should be made in writing to the College's Freedom of Information Officer (see section 7.0 below) and, in general, public authorities have 20 working days to respond.
- 5.3 A fee may be charged which will be notified to you and calculated according to ICO Fees Regulations. Where a fee is applicable the 20 working-day time limit will pause from the day we give the Fees Notice until the day we receive payment. The clock will restart the day after we receive the fee.
- 5.4 Should the requester fail to pay the fee within three months of the College issuing the Fees Notice, then the College is no longer obliged to comply with the request under section 9(2) of FOIA.

6. Copyright

- 6.1 Publications are subject to copyright protection. Where the protection refers to publications published by the College, you must contact the College and obtain permission in writing before content can be copied, redistributed or published in any manner.
- 6.2 Where the College grants permission it is always conditional on the College being clearly identified as the source of the material and as holding the copyright. Where copyright refers to other organisations you must obtain authorisation to reproduce such material from the copyright holder concerned.
