Governors

Jo Adey

As a serving Royal Navy officer, during her 30 year career Jo has specialised in all aspects of learning and development, in particular how to meet the organisation's strategic skills requirements with a motivated and adaptable workforce. Currently Commander Maritime Reserves, Jo has worked for all three Services and the Ministry of Defence across the training and personnel domains in roles centred around the importance of people and their through-life development. Alongside his academic role, Chris brings extensive governance and strategic leadership experience, including oversight of large budgets, staff teams and complex organisations. He is committed to widening opportunity, supporting high-quality education and skills development, and ensuring education plays a central role in building a fairer, more informed society.

Chris was appointed to the Board of Governors in 2026 and is a member of the Quality & Standards Committee.

Rebecca Bunting

Professor Rebecca Bunting is an experienced senior leader in UK higher education with a distinguished career spanning more than four decades. Most recently she was Vice-Chancellor and Chief Executive of the University of Bedfordshire and before that held the same role at Buckinghamshire New University and the role of Deputy Vice-Chancellor at the University of Portsmouth.

Professor Bunting's research and publications are in the field of English and language development. She was a founding Director of the Higher Education Academy and its successor, Advance HE, and led national and international education and training projects for English Language Teaching. She has chaired several national and regional committees in the higher education sector in relation to learning and teaching, widening participation, social mobility, strategy, leadership, and research.

At a regional level she has been influential in developing approaches to skills and employability, having been a member of two Local Economic Partnership boards, and she established sector leading Civic University Agreements in Bedfordshire.

Professor Bunting has governance experience at University, College and School level. She joined the Board in February 2026 and is a member of the Resources Committee.

Matt Chinn

Dr Matt Chinn is a former Government Scientist and Senior Civil Servant who has worked in Defence and Security for over 33 years. He has a PhD in Chemistry and is a Fellow of the Royal Society of Chemistry. Before retiring in 2025 from his most recent role as Director of Science Operations and Research at the Animal Plant Health Agency, Matt was the Chief Delivery Officer for the Defence Science and Technology Laboratory. He was responsible for leadership and delivery of >4,000 scientists and engineers and a £1B annual budget and had a range of roles in four Government departments - all relating to delivery of scientific research to protect the UK's Defence and Security.
